Most of the exporters, importers, Custom Housing Agents (CHAs), Chartered Accountants and Tax consultants attended the seminar.

KCCI President, Shri M. Ganesh Kamath presented his welcome address. KCCI Hon. Treasurer, CA Abdur Rahman Musba introduced the speakers to the members present. Mr. Mihir Shah further mentioned about getting the Status Holder Certification, an export performance would be necessary in all the three preceding financial years (and in all the two preceding financial years for Gems and Jewellery Sector).
